- **2. Age:** As per O.M No. ABP.6/2016/51,dated 02/09/2020 the candidates must not be less than 18 years and more than 40 years of age as on 01.01.2020. The upper age limit relaxation is as follows:
- (a) 5 years for SC/ST candidates.
- (b) 3 years for OBC/MOBC candidates.
- (c) 2 years for Ex-servicemen.

3. Educational Qualification:

- a. **For Grade-III posts-** As per Schedule-I Rule 3 (3) of Assam Houses, State Guest Houses and Secretariat P.A.B.X. (Officers and Staff) Service Rules, 1992 (as amended, 17th July, 2020) The applicants must be Graduate in any discipline from a recognized University and must possess a minimum 6 (six) months Diploma/Certificate in computer proficiency from a recognized institute.
- b. **For Driver posts** As per Schedule-I Rule 3 (3) of Assam Houses, State Guest Houses and Secretariat P.A.B.X. (Officers and Staff) Service Rules, 1992 (as amended, 17th July, 2020) The applicant shall have the minimum academic qualification of HSLC pass and a driving license from a recognized authority. Applicant shall have to qualify in a written test and driving test as prescribed in these rules.
- c. **For Grade-IV posts-** As per Schedule-I Rule 3 (3) of Assam Houses, State Guest Houses and Secretariat P.A.B.X. (Officers and Staff) Service Rules, 1992 (as amended, 17th July, 2020) The applicant shall have the minimum academic qualification of HSLC pass. Applicant shall have to qualify in a skill turnout and presentation.

Note: The decision of the Selection Committee as to the eligibility or otherwise of a candidate for admission to the examination shall be final.

- 4. Mode of Selection:
- A) **Grade-III Posts:** The candidates whose applications are accepted will be required to appear in an objective type written test the venue and date for which will be notified at a later date. The syllabus of the objective Type Written Test will be as follows:

- **B)** Grade-III Posts (Driver): As per Amended Rule-5, intersection of new Rule 5A (iv), for recruitment to the cadre of Driver, the candidate shall have to appear in a Written Test and Driving Test in two phases as stated below:
- a. Phase I: Written Test on Driving Knowledge on Traffic Rules and Traffic Signals of 100 Marks.
- b. Phase II: Shortlisted candidates shall have to appear in a Driving Skill Test of 100 Marks at a notified place.
- C) Grade-IV Posts: For recruitment to the cadre of Class IV posts, the candidates shall have to qualify in Skill Turnout and Presentation. (As per requirement of Assam Bhawan)

<u>Note:</u> Qualified candidates will have to produce all original testimonials i.e. Age proof Certificate, Caste certificate (in case of reserved category candidate), Education Qualification Certificate and Marksheet, Computer Proficiency Certificate; Income and Asset Certificate of the family issued by the competent authority (in case of candidates belonging to EWS), Employment Exchange Registration Certificate, Disability Certificate (in case of PwD candidates).

For those (Grade III) who will have to appear for Language Skills Test in Assamese/Bengali/Bodo/ Alternative English and Computer Test (Practical) the candidate shall have to secure minimum 30 marks to qualify. Marks obtained in the papers shall not be counted for determining the rank.
