**Functions of SVAYEM Sahayak:**


1. To support officials at district level in process management, coordinate in receiving & scrutinizing the applications & in the capacity building of the identified beneficiaries

2. The undersigned reserves the right to reject/modify/cancel the advertisement without any reason thereof.


