For Appointment of Village Heads-cum-Gaon Pradhans under Golaghat Sadar Sub-Division

In partial modification of the Advertisement issued vide eCF No. RKG/710/2023-LR-GLT/173, dtd. 22.06.2026, inviting online applications for appointment to 21 (twenty one) vacant posts of Village Heads-cum-Gaon Pradhans under Golaghat Sadar Sub-Division, it is hereby notified that the vacancies shown at Sl. Nos. 19, 20 and 21 stand withdrawn from the said advertisement, as the concerned villages now fall under the jurisdiction of the Co-District Commissioner, Bokakhat Co-District, Golaghat.

Eligibility Criteria:

1. The applicant must be a citizen of India.
2. The applicant shall have passed at least the HSLC (10th Standard) Examination from a recognized Board/Institution.
3. The applicant must be a permanent resident of the concerned village and must possess land or other immovable property registered in the applicant's name within the area of the concerned village for which the applicant is seeking appointment as Gaon Pradhan.
4. The applicant must be a person of good character and reputation and capable of assisting the Government in the implementation of its policies and programmes.
5. The applicant must have attained the age of 25 years and must not be more than 65 years of age as on the last date of submission of applications.
6. The applicant shall not have more than two living children from a single or multiple partners.
7. The applicant should have a good reputation and should not have been convicted by any Court of Law for an offence involving moral turpitude.
8. The applicant should be physically and mentally fit to discharge the duties and responsibilities of a Village Head-cum-Gaon Pradhan.

Remuneration:

The selected candidates shall be entitled to a fixed monthly remuneration of Rs. 14,000/- (Rupees Fourteen Thousand) only or such remuneration as may be fixed by the Government from time to time.

Documents to be uploaded:

1. Self-attested copies of educational qualification certificate of HSLC (10th Standard) Examination.
2. Self-attested copy of Permanent Residence Certificate (PRC).
3. Self-attested copy of Age Proof Certificate.
4. Self-attested copy of Aadhaar Card/ Voter Identity Card.
5. Self-attested copies of the latest Land Revenue Receipt, Jamabandi, Land Holding Certificate and other relevant land documents pertaining to the concerned village.
6. Affidavit (self-declaration) regarding the number of living children from a single or multiple partners.
7. Any other relevant supporting documents.

General Conditions:

1. Incomplete applications and applications received after the prescribed date shall be summarily rejected.
2. Submitting an application does not guarantee appointment as Village Head-cum-Gaon Pradhan.
3. The District Commissioner, Golaghat reserves the right to cancel, modify or alter the selection process at any stage without assigning any reason thereof.
4. No TA/DA shall be admissible for appearing in the interview or any other stage of the selection process.
5. Canvassing in any form shall lead to disqualification.
6. The appointment shall be governed by the relevant Government Notifications, Orders and Instructions issued from time to time.
7. Online applications shall be accepted only for the above-mentioned 18 (eighteen) vacant posts of Village Heads-cum-Gaon Pradhans under Golaghat Sadar Sub-Division. Applications for vacant jurisdictions under the Co-District Commissioners of Bokakhat, Dergaon and Sarupathar shall be submitted to the respective offices of the concerned Co-District Commissioners.
