

Eligibility Criteria for all the posts prescribed above:

- The candidate must be an Indian Citizen as defined in Article 5 to 8 of the Constitution of India and must be a Permanent Resident of Assam
- The candidate should not be less than 21 years and not more than 38 years of age on 1.1.2022 (5 Years relaxation for STP/SC/STH and 3 Years relaxation for OBC/MOBC).
- 10(ten) years for Persons with Disability (PWD) candidates i.e. up to 48 years irrespective of SC/ST/OBC and General Category candidates.

The Rules & Regulations/Notifications/Orders issued by the Govt. of Assam from time to time will prevail in case of any discrepancy.

How to Apply:

- Candidates have to apply in prescribed form through online mode only. No other mode for submission of application will be accepted.

- ii) All original documents must be produced at the time of interview for physical verification. If documents are found to be not in order, the candidature will be rejected.
- iii) Instructions for filling up the prescribed online form will be available at <http://niyukti.assam.gov.in/forensic/>
- iv) Before applying online, candidates are advised to carefully go through the instructions provided in the above website. Candidates are required to upload a latest passport size photograph, photocopy of the Admit Card/Certificate of HSLC Examination(for age proof), Mark sheets of Graduation and Post Graduation along with Analytical/Research Experience Certificate (if available), Scanned signature and Caste Certificate(in case of reserved category candidate). No documents i.e. the hard copy of the online application form, registration slip, etc. are required to be sent to the Directorate of Forensic Science, Assam.
- v) Before filling up the online application form, candidates are required to scan recent **Passport Size colour Photograph** and make it ready for uploading. The image size should be minimum **20 KB** and should not exceed **50 KB** and the image dimension should be **3.5cm by 2.5cm**. The image format should be in **jpg or jpeg or png**. No other format of image will be accepted. Candidates are also required to scan their **Specimen signature** and make it ready for uploading. Size should be minimum **10 KB** and should not exceed **30 KB** and the image dimension should be **1.5cm by 2.5cm**. The image format should be **.jpg or jpeg or .png**. No other format of image will be accepted. The relevant documents are also required to be scanned for uploading. Size should not exceed **200 KB**. The document format should be **.jpg or .jpeg or .png or .pdf**. No other format will be accepted. Documents required to be uploaded are as follows –
- a) Age Proof (admit card/certificate of HSLC)
 - b) Marksheet of B.Sc.
 - c) Marksheet of M.Sc.
 - d) M. Phil. Certificate (if completed)
 - e) PhD. Certificate (if completed)

Written Test/Interview:

- There will be no written examination for all the above prescribed posts.
- Candidates will be shortlisted and selected on the basis of 70% weightage on academic performance and 30% weightage on viva voce.
- The breakup of the weightage will be:

a) Marks obtained in BSc	= 20% weightage
b) If Hons. in BSc	= 10 marks
c) MSc marks	= 30% weightage
d) M Phil	= 5 marks
e) Ph D	= 5 marks
