In pursuance of the Govt. Notification No. IGN(E)67/2020/213 dated 04-08-2020 and No. CEI(E)21/2019/Pt-I/54 dated 11-01-2021, online application are invited from eligible candidates who are citizen of India as defined in Article 5 & 8 of the constitution of India domiciled in the State of Assam for filling up of the following sanctioned vacant post in the establishment of the Superintending Engineer, Mangaldai Circle, Irrigation, Mangaldai and the Executive Engineer, Mangaldai Investigation Division, Irrigation, Sipajhar as shown below :

**1. Pay Scale**

- i) Grade-IV: - P.B. Rs. 12000/ to Rs. 52000/ + G.P. Rs. 3900/- plus other allowances admissible.

**2. Eligibility Criteria :-**

**A) Qualifying Age :**

- Candidates must not be less than 18 (Eighteen) years and more than 40 (Forty) years as on 1<sup>st</sup> January, 2021.
- Upper age limit is relaxable for 5 years to the candidates who belong SC/ST.
- Upper age limit is relaxable for 3 years to the candidates who belong to OBC/MOBC and 10 years to the candidates belonging to PWD category.
- Age limit of candidates will be calculated on the basis of birth certificates issued by the competent authority or school certificates issued by the recognized institution.
- No other documents shall be accepted in lieu thereof for the purpose.

**B) Education Qualification :- Class – VIII passed.**

**3. How to apply :-**

- The applications must be submitted online through official website “<https://niyukti.assam.gov.in/irrigationmangaldai>” only and no other form of applications will be entertained.
- Since the applications are submitted online, the questions of submission of applications through proper channel in case the candidates are already employed becomes redundant. However such candidate shall intimate their appropriate appointing authorities about the submission of application in writing.

- iii) The candidate should upload self attested scanned copies of the following document :-
- 1) Age Proof Certificate (i.e. Birth Certificates issued by the competent authority or school certificates issued by the recognized institutions).
  - 2) Educational Qualification Certificate.
  - 3) Employment Exchange Registration Card.
  - 4) Caste certificate, in case of candidate applying under the reservation categories.
  - 5) Residential Certificate (PRC/Aadhar/Voter ID etc.)
  - 6) Recent passport size photograph of size 3.5cm x 4.5cm with white Background.
  - 7) In case candidates of PWD category, a certificate from the competent authority is to be submitted.
  - 8) Scanned signature of the candidate (Black Ball Pen preferably).

#### **4. Period for receipt online applications**

- i) Applications will be received online from 11:00 A.M. of 18-02-2021 upto 5 P.M. of 05-03-2021.

#### **5) Issue of Admit Cards/ Call Letters**

- i) The Online Admit Cards/ Call Letters will be available on the official website link and can be downloaded for appearing in “ Written Examination”, whose applications are accepted as per eligibility criteria.
- ii) It may be noted that no separate Admit Cards/ Call Letters will be issued and it will be the responsibility of the applicant to take the printout.
- iii) No body without Admit Card/ Call Letters shall be allowed to enter Examination Center.

#### **6) Selection Procedure**

- i) The candidates, whose applications are accepted will be required to appear in an Objective Type Written Test to be held specified venues as per date, time mentioned in Admit Cards/ Call letters.
- ii) The examination will consist of the following subjects.

- iii) Against each vacancy, 4 (Four) Candidates will be shortlisted on the basis of the marks obtained in the written test.
- iv) The Candidates, shortlisted through written test will have to attend for documents verification and the date, time & venue for documents verification will be intimated to the candidates concerned in due course of time.
- v) The Final Select List will be prepared after documents verification and will contain the names of candidates equal to the number of vacancies advertised and selected.
- vi) The Final Select List will be published in two widely circulated newspapers.

- vii) The appointment will be made on receipt of satisfactory Police Verification Report from the authority concerned.
- vii) At the time of joining, the application have to give an undertaking that they will abide by the Rules of New Pension Scheme issued by the Government.

Note :-

- i) Applicants are advised to submit only a single application.
- ii) Multiple applications from the same candidate may lead to disqualify of the candidate.
- iii) Canvassing directly or indirectly shall disqualify a candidate.
- iv) No manual application form will be accepted.
- v) No TA/ DA is admissible for appearing in the written test and documents verification.
