This is in pursuance of the Govt. letter No.GAG(B).303/2016/143-144, dated 31-10-2020 issued by the government in General Administration Department, Dispur, Assam. ### Terms and conditions:-

Age: Candidate must not be less than 18 years of age and not more than 40 years of age as on 01-.01-2020. The upper age limit is relaxable for candidates belonging to SC/ST categories upto 45 years; for candidates belonging to OBC/MOBC categories upto 43 years; for candidates belonging to ex-Servicemen category upto 42 years and for candidates belonging to Persons with Disabilities category upto 50 years as per Govt. OM No.ABP.06/2016/51; dated 02/09/2020 issued by the government of Assam in Personnel(B) Department.

## 2. Educational qualification:

The minimum educational qualification is Class VIII passed from an institute recognized by State/Central Government

- 3. Applicants must upload the following documents/ testimonials along with the application:-
  - One recent passport size photograph.
  - Specimen Signature
  - · Class VIII passed certificate.
  - · Caste certificate(If applicable)
  - EWS/PWD Certificate issued by the competent authority.
  - Valid Employment Exchange Registration Certificate
  - Experience certificate(If any).
- 4. Candidates already in government service should apply through proper channel.
- 5. Candidates whose applications are accepted as per eligibility criteria will be required to appear in a Written Examination and selection will be strictly on the basis of merit.
- 6. Incomplete applications will be rejected.
- 7. The selection committee shall have the right to accept or reject the candidature of a candidate after proper scrutiny of the documents/testimonials etc. with regards to the modalities of selections. The decision of the selection committee shall be final and binding. The selected candidates will have to submit an undertaking to the appointing authority that they will abide by the new pension rules issued by the Government of Assam in Finance Department vide No.BW.03/2003/Pt-I/1; Date:25/01/2005.
- **8.** The appointment will be made after necessary police verification, document verification and medical examination as per the procedure.

- 14. Final selection will be done on the basis of merit ( Aggregate marks obtained in the Written Test ) and verification of original documents.
- 15. No TA/DA will be admissible for appearing in the Written Test.
- 16. There will be no viva- voce interview.
- 17. Canvassing in any form will lead to disqualification of the candidate.
- 18. In case two or more candidates get equal marks, the selection committee will decide the procedure for final selection. The decision of selection committee in this regard will be final.
- 19. Candidates with Benchmark Disabilities in the category of Orthopedically Handicapped will be allowed to use scribe to write at their own cost subject to the following conditions:
  - Name, Address and Educational Qualifications along with recent photograph of the scribe must be uploaded during online submission of application form.
  - Educational qualification of the scribe should be less than the minimum qualification criteria of ii) the examination.
  - The facility of scribe will be allowed to such candidates on production of a certificate to the effect (iii that the person concerned has physical limitation to write, and scribe is essential to write examination on his/her behalf , from a Medical Officer not below the rank of Sub-Divisional Medical and Health Officer as per the proforma at Appendix –I.
  - The candidates who intend to use their own scribe, will have to submit an undertaking as per iv) proforma at Appendix-II.
